

## Registered Student Organizations Principal Member Agreement

Please read and agree to each section of the Principal Member Agreement

As a principal member of a registered UCSD student organization, I do hereby agree to comply with the UNIVERSITY OF CALIFORNIA POLICIES APPLYING TO CAMPUS ACTIVITIES, ORGANIZATIONS AND STUDENTS AND UC San Diego policies and procedures, including Student Conduct Regulations, which include but are not limited to:

- I. POLICY ON REGISTERED CAMPUS ORGANIZATIONS A Registered Campus Organization is an organization whose membership predominantly comprises students, faculty, and/or staff of a particular University campus, and that attains recognition as a Registered Campus Organization by complying with the requirements and procedures set forth in campus implementing regulations. Membership in a Registered Campus Organization shall be open to any student, consistent with the Nondiscrimination Policy Statement for University of California Publications Regarding Student-Related Matters, with the exception that membership in an officially recognized sorority or fraternity may be limited by gender. - II. NONDISCRIMINATION POLICY STATEMENT FOR REGISTERED STUDENT ORGANIZATIONS UNIVERSITY OF CALIFORNIA REGARDING STUDENT-RELATED MATTERS The University of California, and UCSD in accordance with applicable Federal and State law and University policy, does not discriminate on the basis of race, color, national origin, religion, sex, gender identity, pregnancy, disability, age, medical condition (cancerrelated), ancestry, marital status, citizenship, sexual orientation, or status as a Vietnam-era veteran or special disabled veteran. The University and UCSD also prohibit sexual harassment. This nondiscrimination policy covers admission, access, and treatment in University programs and activities. The applicants certify that the organization will not discriminate on the basis of race, color, national origin, religion, sex, gender identity, pregnancy, physical or mental disability, medical condition (cancer related or genetic characteristics), ancestry, marital status, age, sexual orientation, citizenship, or service in the uniformed services. This certification shall override any language to the contrary in the organization's bylaws, constitution, or other documents. Complaints about harassment or discrimination may be referred to the Office for the Prevention of Harassment and Discrimination (http://ophd.ucsd.edu) for investigation.

- III. HAZING No Student organization or other person attending UCSD shall knowingly commit, participate in, or conspire to commit in any manner, acts of hazing. "Participation in hazing or any method of initiation or pre-initiation into a campus organization or other activity engaged in by the organization or members of the organization at any time that causes, or is likely to cause, physical injury or personal degradation or disgrace resulting in psychological harm to any student or other person." - IV. UNIVERSITY NAME "A registered student organization shall not use the name of the University of California, University of California, San Diego, or abbreviations thereof as a part of its own name except in accordance with University policies and UCSD regulations. The geographical designation "at UCSD" may be used by any student organization as part of its name without obtaining special approval." (UC SAN Diego PPM 510 10, Sec. IV, D3) UCSD (http://students.ucsd.edu/student-life/\_organizations/student-conduct/regulations/17.00.html) UCSD (http://adminrecords.ucsd.edu/ppm/docs/510-10.HTML#UC%20Name/Campus%20Name) Student organizations using the word "Tritons" as a part of their name agree to the following conditions: (1) the complete name of the organization must always be used in any public setting; (2) the word "Tritons" must not be used in greater prominence than the other words in the student organization's name; and (3) use of the word "Tritons" in a student organization's name must not impart (expressly or by implication) any endorsement or sponsorship by the University of the student organization or its activities. Student organizations also expressly acknowledge that permission to use any UCSD

trademark must be specifically obtained in accordance with University/UCSD policies, and that the foregoing does not represent permission to use UCSD trademarks in any manner, including the production of logoed products (such as t-shirts, sweatshirts, caps, etc.) using UCSD trademarks.

- V. MEMBERSHIP Only registered UCSD students may hold office in the organization. Only registered UCSD students may vote in elections for the selection of the organization's officers. Only registered principal members are authorized to officially conduct business with UCSD or the University, e.g., calendar events, reserve facilities, access budget numbers or spend student organization funds. By signing this agreement, the principal members are stating that they are personally responsible for the organization's debts and all its other financial liabilities. If a principal member chooses not to accept this responsibility she/he must submit a written request to CSI to be deleted as a principal member. The organization shall meet at least once annually. (Office of Student Conduct Regulations, 17.10.11.11)

- VI. FUNDRAISING -The activity of fund raising through sale of goods/services or through production of events cannot be continuous so as to take the form of a commercial enterprise unless specifically authorized by the Vice Chancellor for Business and Finance. Refer to Section X, para. B. of this PPM for the definition of commercial. Fundraising which inures to the personal gain of any person other than through a contractual arrangement is not permitted. - VII. INDEMNIFICATION The registered student organization and its members agree to indemnify and hold harmless the Regents, the University, its officers, agents and employees from and against any and all claims, unless due to willful or negligent acts or omissions of the University.
